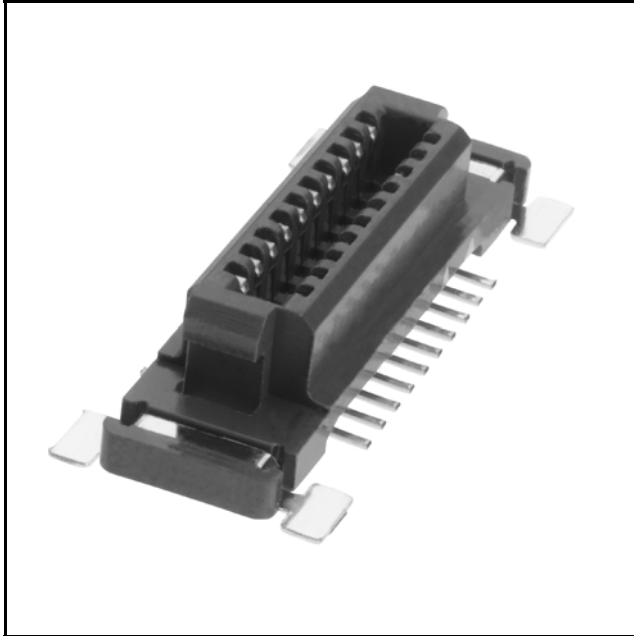

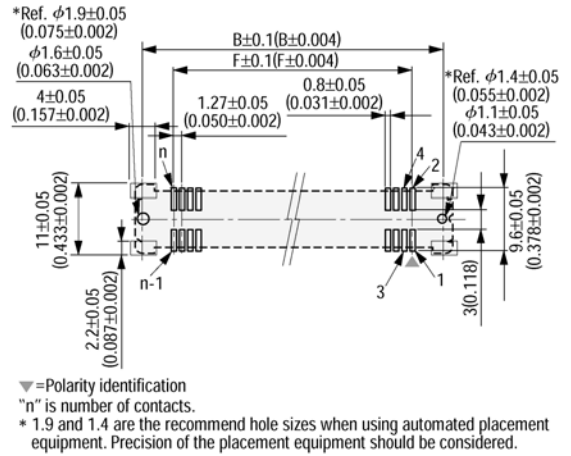

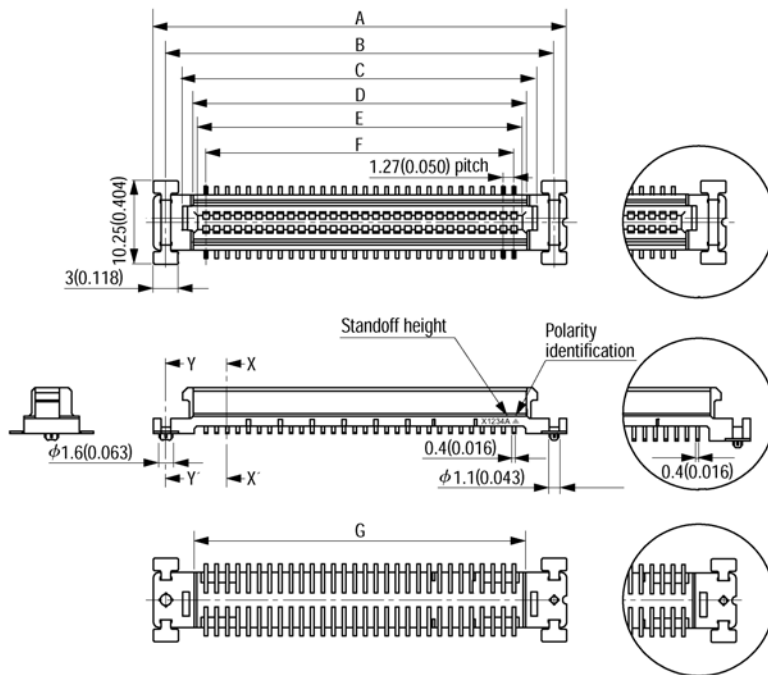

(Component Side View)

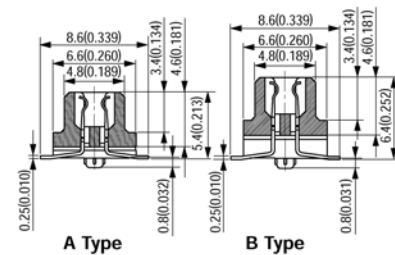


A Type (Standoff height)

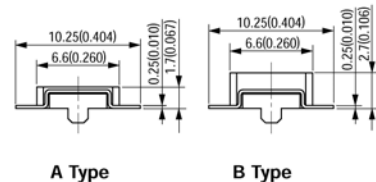
B Type
