




The QEE12X is a 880 nm AlGaAs LED encapsulated in a medium wide angle, plastic sidelooker package.


Package Dimensions




Figure 1. Normalized Intensity vs. Wavelength 1.0 0.9 0.8 NORMALIZED INTENSITY 0.7 0.6 0.5 0.4 0.3 0.2 0.1 750 800 850 900 950 1,000 1,050 λ (nm)













Typical Performance Curves (Continued)
