


FIG.1 FORWARD CURRENT VS. FORWARD VOLTAGE.




FIG.3 REVERSE CURRENT VS. REVERSE VOLTAGE.




FIG.5 MAXIMUM FORWARD DC CURRENT VS AMBIENT TEMPERATURE (Timax=110 °C)




FIG.2 RELATIVE LUMINOUS INTENSITY VS. FORWARD CURRENT






FIG.4 RELATIVE LUMINOUS INTENSITY VS. WAVELENGTH.




## **Mechanical Dimensions**






## **Package**

#### **Features:**

- The LEDs are packed in cardboard boxes after packaging in normal or anti-electrostatic bags.
- Cardboard boxes will be used to protect the LEDs from mechanical shock during transportation.
