Description

PLA150 is a 250V, 250mA, 7Ω , single-pole, normally open (1-Form-A) solid state relay that uses optically coupled MOSFET technology to provide $3750V_{rms}$ input to output isolation. Efficient MOSFET switches and photovoltaic die use Clare's patented OptoMOS architecture. The optically coupled output is controlled by a highly efficient GaAIAs infrared LED.

This performance leader features high peak load current handling capability with a very low on-resistance.






AC/DC Configuration

Moisture Sensitivity

Board Wash

Clare recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since Clare employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.











