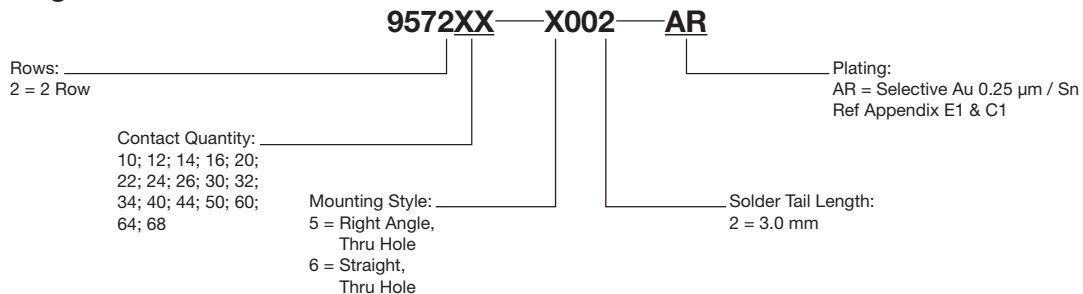
PCB-Layout
