



Figure 1. Functional schematic (top view)



#### **Description**

The HSP061-4NY8 is a 4-channel ESD array with a rail to rail architecture designed specifically for the protection of high speed differential lines.

The ultra-low variation of the capacitance ensures very low influence on signal-skew. The large bandwidth and the low reflection make it compatible with 5 Gbps.

The device is packaged in  $\mu$ QFN-8L with a 400  $\mu$ m pitch, which minimizes the PCB area.



Figure 3. S21 attenuation measurement








Figure 4. Differential impedance (Z<sub>diff</sub>)<sup>(1)</sup>

Figure 6. ESD response to IEC 61000-4-2 (+8 kV contact discharge)






Figure 7. ESD response to IEC 61000-4-2 (-8 kV contact discharge)

Figure 8. Ordering information scheme










Figure 11.  $\mu$ QFN-8L tape and reel specification




Figure 12. Recommended stencil window position

# 4.1 Solder paste

- 1. Use halide-free flux, qualification ROL0 according to ANSI/J-STD-004.
- 2. "No clean" solder paste recommended.
- 3. Offers a high tack force to resist component displacement during PCB movement.
- 4. Use solder paste with fine particles: powder particle size 20-45 μm.

#### 4.2 Placement

- 1. Manual positioning is not recommended.
- 2. It is recommended to use the lead recognition capabilities of the placement system, not the outline centering.
- 3. Standard tolerance of ± 0.05 mm is recommended.
- 4. 3.5 N placement force is recommended. Too much placement force can lead to squeezed out solder paste and cause solder joints to short. Too low placement force can lead to insufficient contact between package and solder paste that could cause open solder joints or badly centered packages.
- 5. To improve the package placement accuracy, a bottom side optical control should be performed with a high resolution tool.
- For assembly, a perfect supporting of the PCB (all the more on flexible PCB) is recommended during solder paste printing, pick and place and reflow soldering by using optimized tools.

#### 4.3 PCB design

- To control the solder paste amount, the closed via is recommended instead of open
- The position of tracks and open vias in the solder area should be well balanced. The symmetrical layout is recommended, in case any tilt phenomena caused by asymmetrical solder paste amount due to the solder flow away.




Figure 13. Printed circuit board layout recommendations




Figure 14. ST ECOPACK® recommended soldering reflow profile for PCB mounting
