






N-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted










P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted
