TEPT5600 ambient light sensor is a silicon NPN epitaxial planar phototransistor in a T-1¾ package. It is sensitive to visible light much like the human eye and has peak sensitivity at 570 nm.




Fig. 1 - Power Dissipation Limit vs. Ambient Temperature




Fig. 1 - Collector Dark Current vs. Ambient Temperature




Fig. 2 - Relative Photo Current vs. Ambient Temperature




Fig. 3 - Photo Current vs. Collector Emitter Voltage




Fig. 4 - Photo Current vs. Illuminance




Fig. 5 - Collector Emitter Capacitance vs. Collector Emitter Voltage




Fig. 6 - Relative Spectral Sensitivity vs. Wavelength






Fig. 7 - Relative Radiant Sensitivity vs. Angular Displacement
