



Fig. 1 - Test Circuit for dV/dt_{cr} and dV/dt_{crq}




Fig. 3 - Motor Control Circuit




Fig. 4 - Derating Diagram




Fig. 5 - Test Pulse Diagram for Sample Test according to DIN EN 60747-5-5/DIN EN 60747-; IEC60747




Fig. 6 - Total Power Dissipation vs. Ambient Temperature




Fig. 7 - Forward Current vs. Forward Voltage




Fig. 8 - Relative Threshold Forward Current vs. Ambient Temperature




Fig. 9 - Relativ On-State Current vs. Ambient Temperature




Fig. 10 - Off-State Current vs. Ambient Temperature




Fig. 11 - On-State Current vs. Ambient Temperature





Fig. 12 - On-State Current vs. Ambient Temperature


