




Figure 1. Collector current as a function of switching frequency ($7_{\rm i}$ ≤175°C, D=0.5, $V_{\rm CE}$ =600V, $V_{\rm GE}$ =15/0V, $R_{\rm G}$ =35 Ω)




Figure 2. Forward bias safe operating area (D=0, T_C =25°C, T_j ≤175°C; V_{GE} =15V)




Figure 3. Power dissipation as a function of case temperature $(T_i \le 175^{\circ}C)$




Figure 4. Collector current as a function of case temperature ($V_{\text{GE}} \ge 15\text{V}$, $T_{\text{j}} \le 175^{\circ}\text{C}$)






Figure 5. Typical output characteristic $(T_i=25^{\circ}\text{C})$




Figure 6. Typical output characteristic




Figure 7. Typical transfer characteristic (V_{CE} =20V)




Figure 8. Typical collector-emitter saturation voltage as a function of junction temperature (V_{GE} =15V)






Figure 9. Typical switching times as a function of collector current (ind. load, *T*_i=175°C, *V*_{CE}=600V, *V*_{GE}=15/0V, *R*_G=35Ω, test circuit in Fig. E)




Figure 10. Typical switching times as a function of gate resistor (ind. load, $T_{\rm j}$ =175°C, $V_{\rm CE}$ =600V, $V_{\rm GE}$ =15/0V, $V_{\rm CE}$ =15A, test circuit in Fig. E)




Figure 11. Typical switching times as a function of junction temperature (ind. load, V_{CE}=600V, V_{GE}=15/0V, I_C=15A, R_G=35Ω, test circuit in Fig. E)




Figure 12. Gate-emitter threshold voltage as a function of junction temperature (\(\ell_{\mathcal{e}} = 0.5 mA \)






Figure 13. Typical switching energy losses as a function of collector current (ind. load, T_j =175°C, V_{CE} =600V, V_{GE} =15/0V, R_{G} =35 Ω , test circuit in Fig. E)




Figure 14. Typical switching energy losses as a function of gate resistor (ind. load, 7j=175°C, V_{CE}=600V, V_{GE}=15/0V, I_C=15A, test circuit in Fig. E)




Figure 15. Typical switching energy losses as a function of junction temperature (ind load, V_{CE} =600V, V_{GE} =15/0V, I_{C} =15A, I_{G} =35 Ω , test circuit in Fig. E)




Figure 16. Typical switching energy losses as a function of collector emitter voltage (ind. load, T_j =175°C, V_{GE} =15/0V, I_{C} =15A, R_{G} =35 Ω , test circuit in Fig. E)






Figure 17. Typical gate charge




Figure 18. Typical capacitance as a function of collector-emitter voltage (VGE=0V, f=1MHz)




Figure 19. Typical short circuit collector current as a function of gate-emitter voltage (VcE≤600V, start at 7j=25°C)




Figure 20. Short circuit withstand time as a function of gate-emitter voltage ($V_{CE} \le 600V$, start at $T_j \le 150$ °C)






Figure 21. IGBT transient thermal impedance $(D=t_0/T)$




Figure 22. Diode transient thermal impedance as a function of pulse width $(D=t_0/T)$




Figure 23. Typical reverse recovery time as a function of diode current slope (\(\nu_R = 600V\))




Figure 24. Typical reverse recovery charge as a function of diode current slope (V_R =600V)






Figure 25. Typical reverse recovery current as a function of diode current slope (V_R =600V)




Figure 26. Typical diode peak rate of fall of reverse recovery current as a function of diode current slope $(V_R=600V)$




Figure 27. Typical diode forward current as a function of forward voltage







Figure 28. Typical diode forward voltage as a function of junction temperature







Figure C. Definition of diodes switching characteristics




Figure A. Definition of switching times




Figure D. Thermal equivalent circuit


