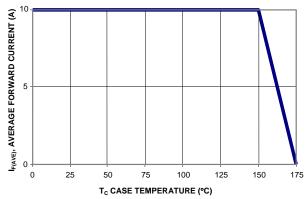

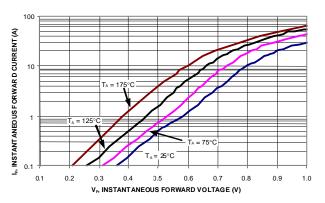


Figure 2: Typical Forward Characteristics, Per Element

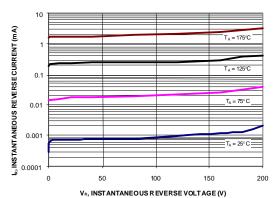


Figure 3: Typical Reverse Characteristics, Per Element
