


Figure 1. Forward Current vs. Forward Voltage




Figure 3. Reverse Current vs. Reverse Voltage




Figure 2. Forward Current vs. Forward Voltage




Figure 4. Diode Capacitance vs. Reverse Voltage








Package Dimensions in millimeters (inches): Quadro MELF SOD80
