


Figure 1. Forward Current vs. Forward Voltage




Figure 2. Admissible Forward Current vs. Ambient Temperature




Figure 3. Admissible Power Dissipation vs. Ambient Temperature




Figure 4. Dynamic Forward Resistance vs. Forward Current




Figure 5. Leakage Current vs. Junction Temperature




Figure 6. Capacitance vs. Reverse Voltage


