
#### N-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




#### N-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






#### N-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

#### P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






#### P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






#### P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted
