




Figure 1. On-Region Characteristics




Figure 2. Transfer Characteristics




Figure 3. On-Resistance Variation vs. Drain Current and Gate Voltage




Figure 4. Body Diode Forward Voltage Variation vs. Source Current and Temperature




Figure 5. Capacitance Characteristics






Figure 6. Gate Charge Characteristics




#### **Gate Charge Test Circuit & Waveform**



### **Resistive Switching Test Circuit & Waveforms**





#### **Unclamped Inductive Switching Test Circuit & Waveforms**



#### Peak Diode Recovery dv/dt Test Circuit & Waveforms




