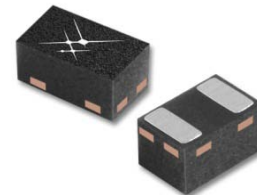

## Description

The SMS7621-040LF is a plastic packaged, surface mountable low barrier Schottky diode designed for sensitive detector applications to 20 GHz and higher. The low capacitance of this diode (0.25 pF) combined with its low total resistance (18  $\Omega$  typical at 5 mA) make the SMS7621-040LF particularly well suited for sensitive detector circuits.

The SMS7621-040LF is also available in a variety of plastic packages and configurations that include an SOT-23 (the SMS7621-001LF), a small footprint SC-79, and a miniature SC-70.

### Electrical and Mechanical Specifications

The absolute maximum ratings of the SMS7621-040LF are provided in Table 1. Electrical specifications are provided in Table 2.

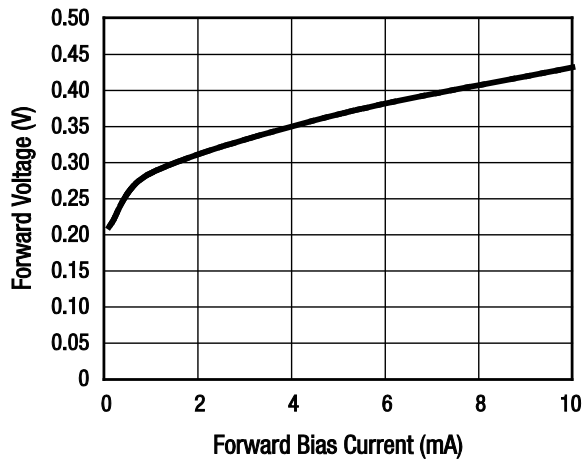


Figure 1. Forward Voltage vs Forward Current

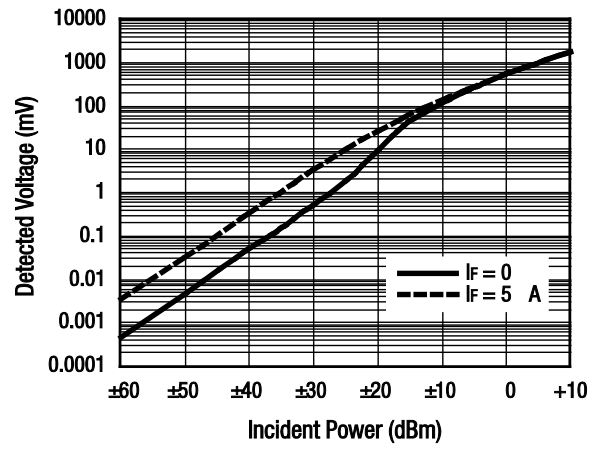


Figure 2. Detector Voltage @ 2.45 GHz

Typical performance characteristics of the SMS7621-040LF are illustrated in Figures 1 and 2.

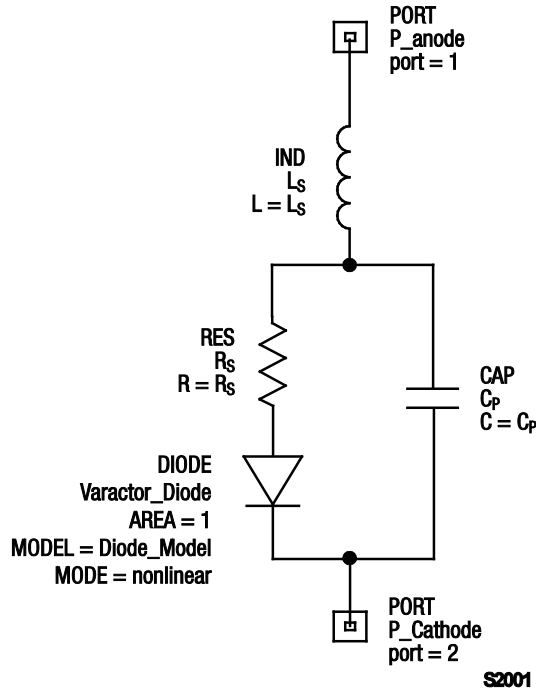
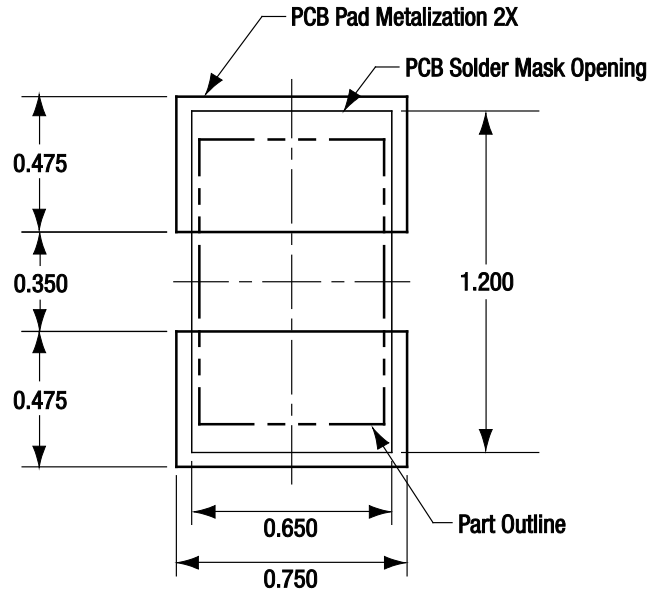


Figure 3. SMS7621-040LF SPICE Model

The SPICE model for the SMS7621-040LF is shown in Figure 3 and the associated model parameters are provided in Table 3.

### Package Dimensions

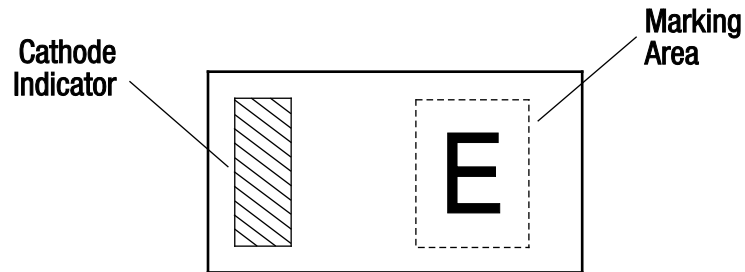
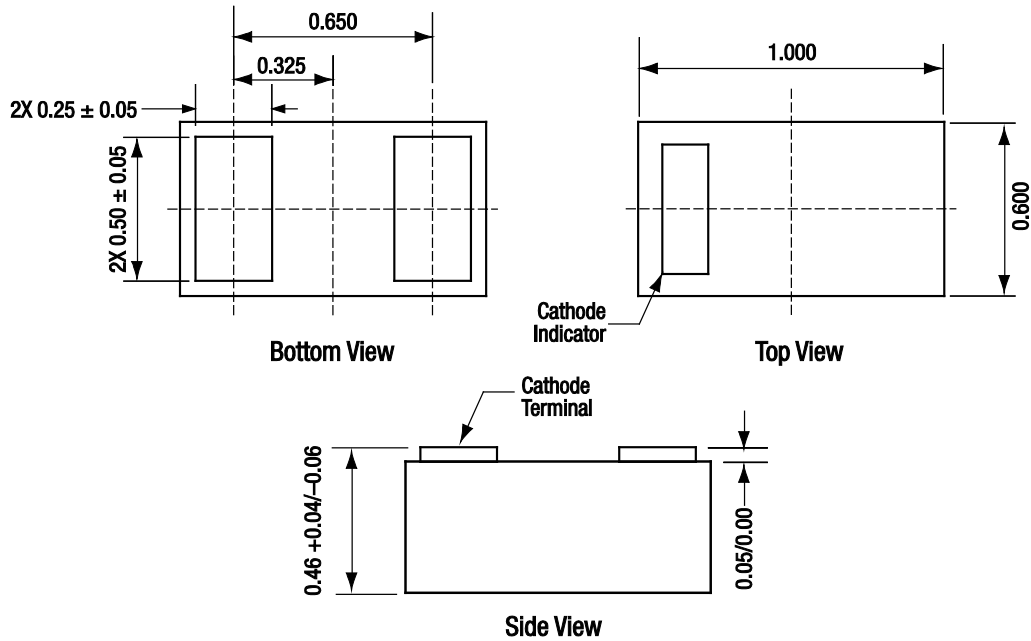


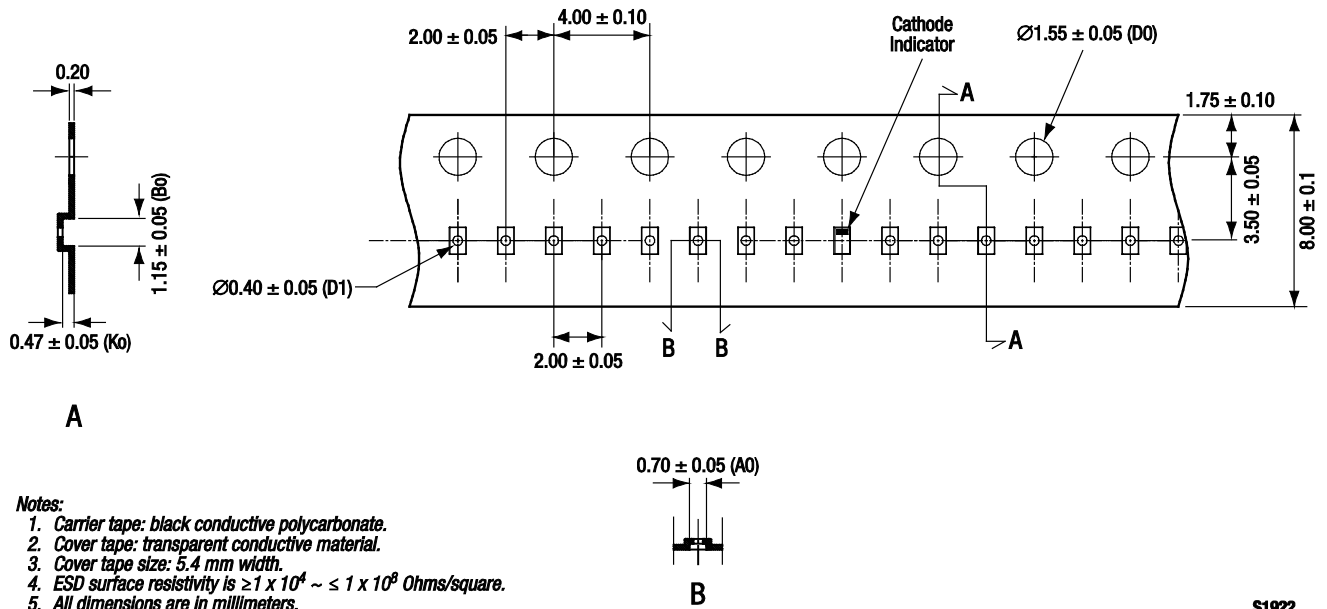
Figure 5. Typical Case Markings (Top View)

The PCB layout footprint for the SMS7621-040LF is provided in Figure 4. Typical case markings are shown in Figure 5. Package dimensions for the SMS7621-040LF are provided in Figure 6. Tape and reel dimensions are provided in Figure 7.

### Package and Handling Information

Instructions on the shipping container label regarding exposure to moisture after the container seal is broken must be followed. Otherwise, problems related to moisture absorption may occur when the part is subjected to high temperature during solder assembly.

The SMS7621-040LF is rated to Moisture Sensitivity Level 1 (MSL1) at 260 °C. It can be used for lead or lead-free soldering. For additional information, refer to the Skyworks Application Note, *Solder Reflow Information*, document number 200164.

Care must be taken when attaching this product, whether it is done manually or in a production solder reflow environment. Production quantities of this product are shipped in a standard tape and reel format.

(100 k $\Omega$  Video Resistance)

Figure 4. SMS7621-040LF PCB Layout Footprint
