






Bottom View

Bottom View Pin-Out











Derating Curve

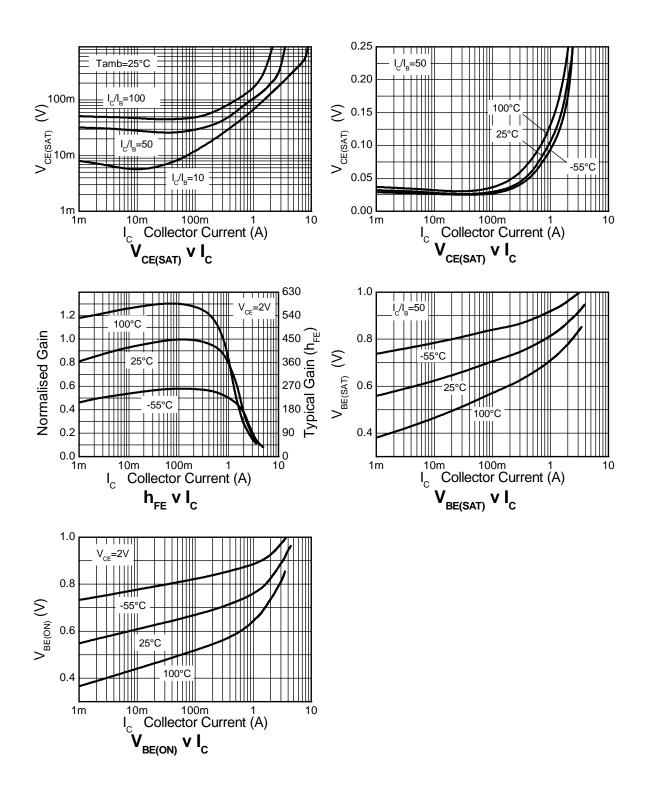




Typical Electrical Characteristics





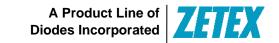
