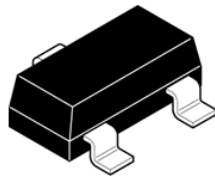

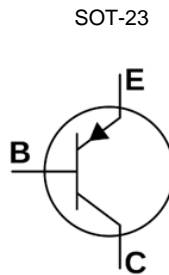

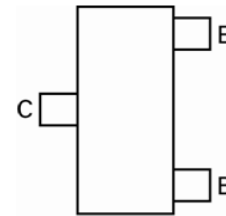

Device symbol



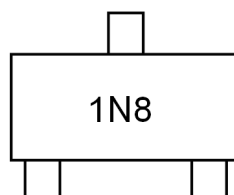

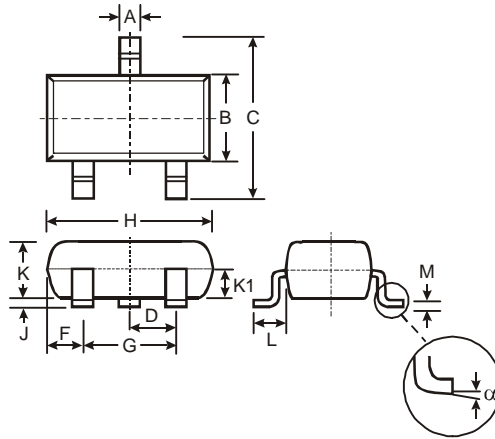

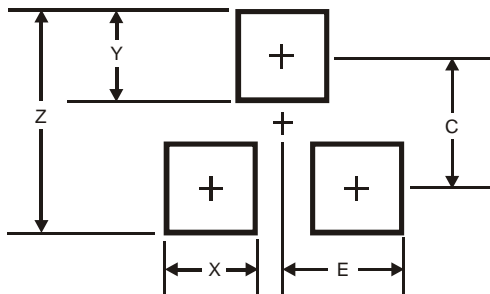
