


## **Application Example**

## **■** Clog Avoidance

The D6F-W air flow sensor detects the pressure drop over the filter as it becomes more completely contaminated with particles. The moment the drop exceeds a certain threshold, a warning signal is sent out, indicating the need for filter replacement.
