SECTION 3: HAZARD IDENTIFICATION**Emergency Overview:** White, opaque paste; no odor. This product is nonflammable. Paste will cause acute but mild irritation of the eyes and skin under repeated or prolonged exposure.**Potential Health Effects:****Eyes:** Product is irritating and can cause acute but mild tearing, reddening accompanied by a stinging sensation.**Skin:** Contact with product can cause acute but mild skin irritation.**Ingestion:** Irritating to mouth, throat and stomach.
