


Fig. 1 Forward Current vs. Forward Voltage




Fig. 2 Forward Current vs. Forward Voltage






Fig. 3 Reverse Current vs. Junction Temperature




Fig. 4 Diode Capacitance vs. Reverse Voltage




Fig. 5 Typ. Non Repetitive Forward Surge Current vs. Pulse width





- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
