## **Description**

The SMV1405-SMV1430 group of silicon abrupt junction varactor diodes is designed for use in Voltage Controlled Oscillators (VCOs) requiring tight capacitance tolerances. The low resistance of these varactors makes them appropriate for high-Q resonators in wireless system VCOs to frequencies above 2.5 GHz. This family of varactors is characterized for capacitance over temperature.

Table 1 describes the various packages and markings of the SMV1405-SMV1430 group of varactors.

### **Electrical and Mechanical Specifications**




Figure 1. Capacitance vs Reverse Voltage




Figure 2. Relative Capacitance Change vs Temperature

The absolute maximum ratings of the SMV1405-SMV1430 varactors are provided in Table 2. Electrical specifications are provided in Table 3. Typical capacitance values are listed in Table 4. Typical performance characteristics of the SMV1405-SMV1430 varactors are illustrated in Figures 1, 2, and 3.

The SPICE model for the SMV1405- SMV1430 varactors is shown in Figure 4 and the associated model parameters are provided in Table 5.

Package dimensions are shown in Figures 5 to 9 (odd numbers), and tape and reel dimensions are provided in Figures 6 to 10 (even numbers).

#### **Package and Handling Information**

Instructions on the shipping container label regarding exposure to moisture after the container seal is broken must be followed.

Otherwise, problems related to moisture absorption may occur when the part is subjected to high temperature during solder assembly.

The SMV1405- SMV1430 series of varactors are rated to Moisture Sensitivity Level 1 (MSL1) at 260 °C. They can be used for lead or lead-free soldering. For additional information, refer to the Skyworks Application Note, *Solder Reflow Information*, document number 200164.

Care must be taken when attaching this product, whether it is done manually or in a production solder reflow environment. Production quantities of this product are shipped in a standard tape and reel format.





Figure 3. Capacitance vs Reverse Voltage (SMV1430)





Figure 5. SC-70 Package Dimensions



Figure 7. SC-79 Package Dimensions




Figure 8. SC-79 Tape and Reel Dimensions




Figure 9. SOT-23 Package Dimensions




Figure 10. SOT-23 Tape and Reel Dimensions
