Description

The NC7WZ07 is a dual buffer with open drain outputs from Fairchild's Ultra-High Speed (UHS) series of TinyLogic®. The device is fabricated with advanced CMOS technology to achieve ultra-high speed with high output drive while maintaining low static power dissipation over a broad V_{CC} operating range. The device is specified to operate over a very broad V_{CC} operating range. The device is specified to operate over the 1.65V to 5.5V V_{CC} range. The inputs and outputs are high impedance when V_{CC} is 0V. Inputs tolerate voltages up to 7V independent of V_{CC} operating voltage.

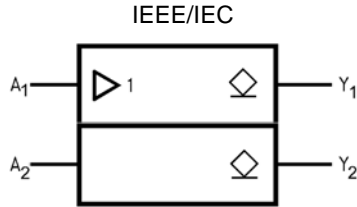


Figure 1. Logic Symbol

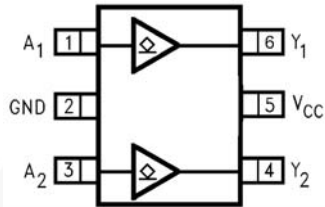


Figure 2. SC70 (Top View)

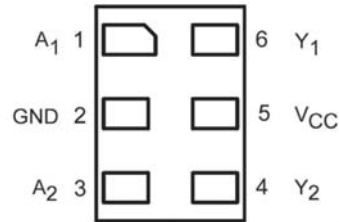


Figure 3. MicroPak™ (Top Through View)

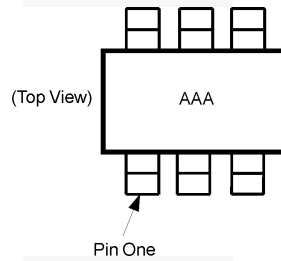


Figure 4. Pin 1 Orientation

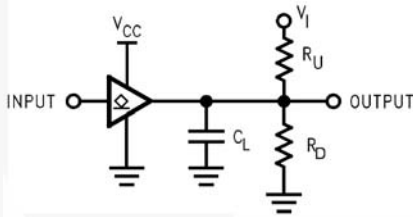


Figure 5. AC Test Circuit

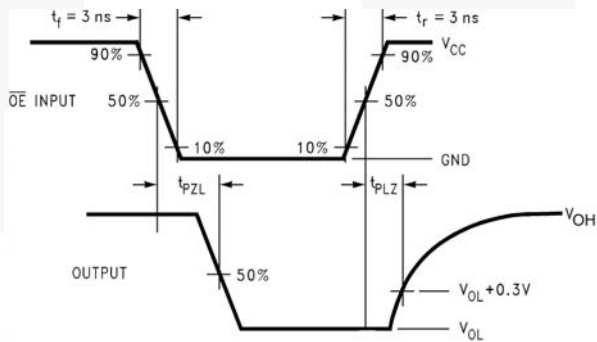


Figure 6. AC Waveforms

7. Input PRR = 1.0MHz, t_w = 500ns.

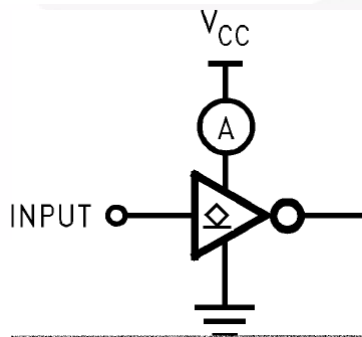


Figure 7. I_{CCD} Test Circuit

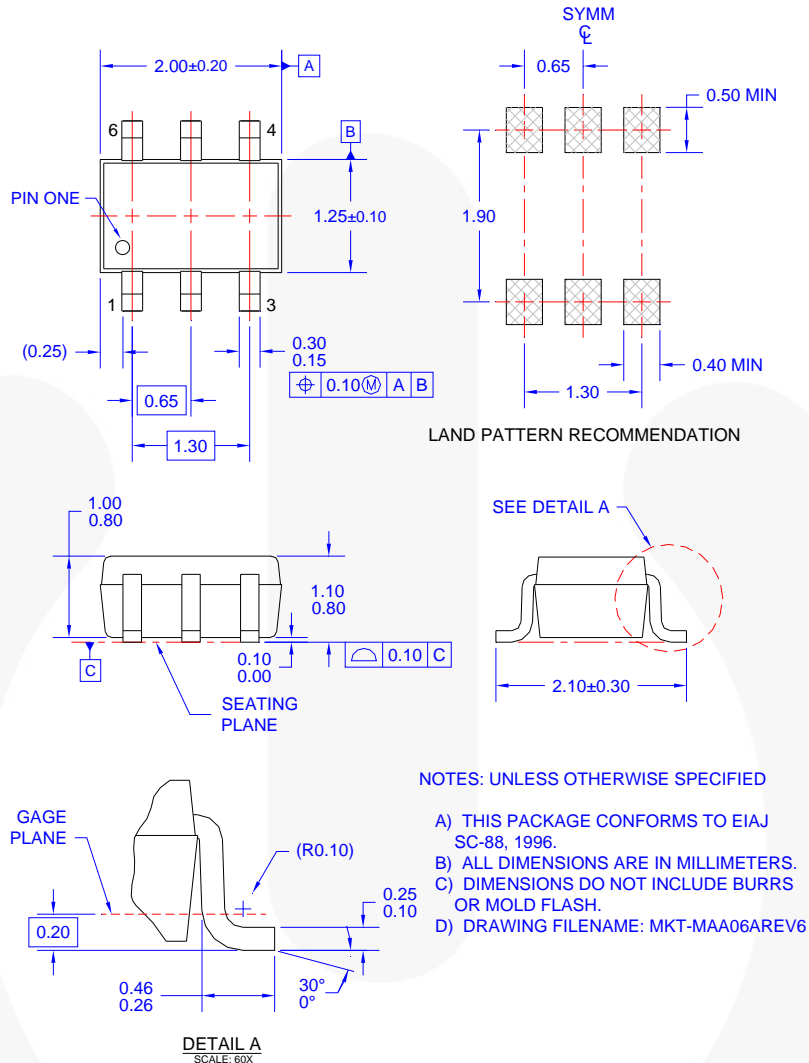


Figure 8. 6-Lead, SC70, EIAJ SC88, 1.25mm Wide

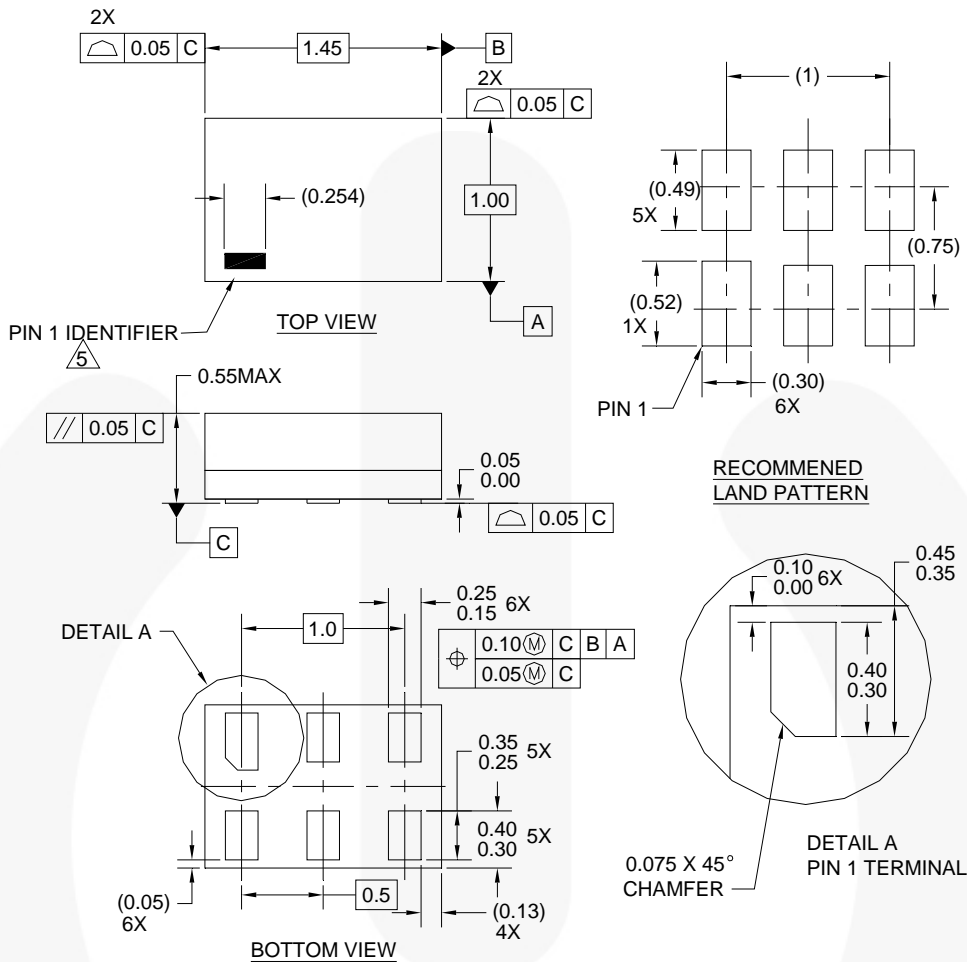

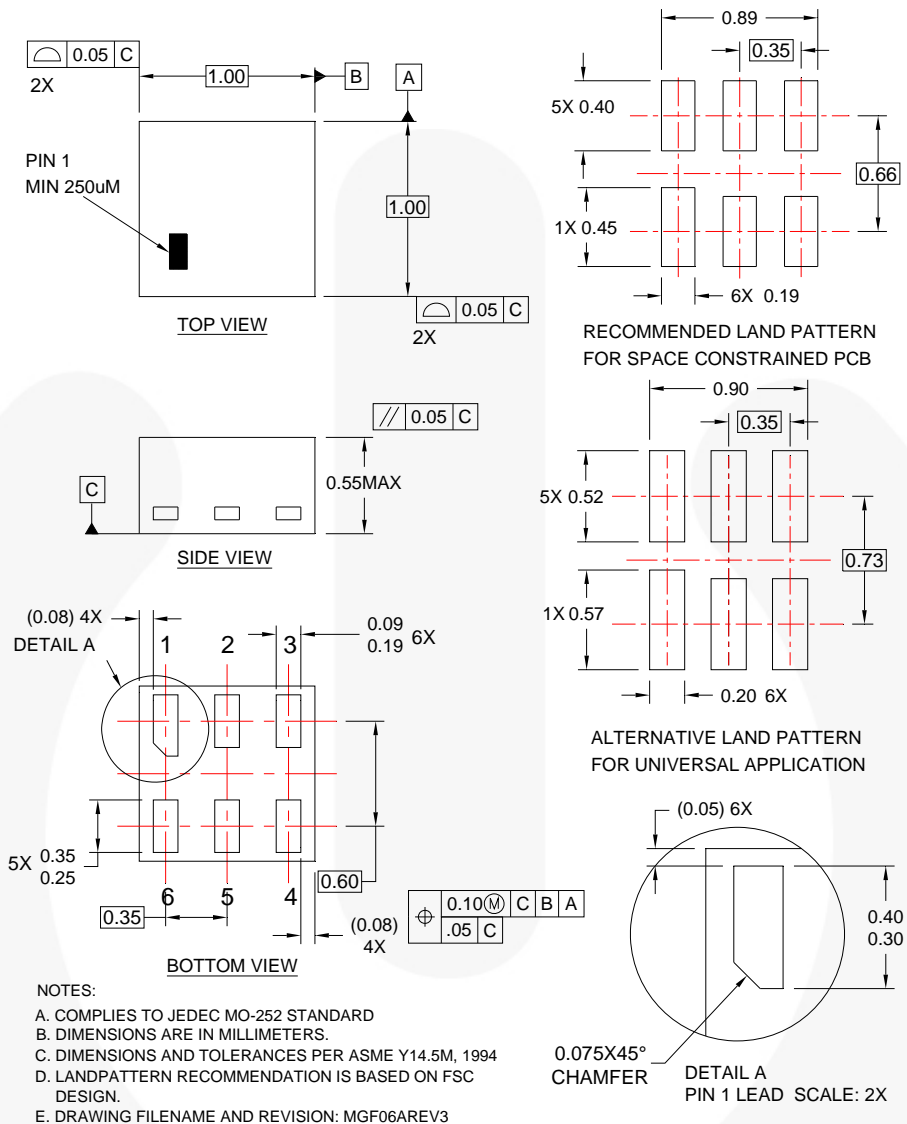


Figure 10. 6-Lead, MicroPak2™, 1x1mm Body, .35mm Pitch


