


Caution for Gate 1 switch-off mode:


No external DC-voltage on Gate 1 in active mode! Switch-off at Gate 1 with V_{G1S} < 0.7 V is feasible.

Using open collector switching transistor (inside of PLL), insert 10 k Ω collector resistor.




Dimensions of S904T in mm









Dimensions of S904TR in mm

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
