High-Frequency NPN Transistor Array For Low-Power Applications at Frequencies Up to 1.5GHz

The CA3227 consists of five general purpose silicon NPN transistors on a common monolithic substrate. Each of the transistors exhibits a value of f_{T} in excess of 3GHz, making them useful from DC to 1.5GHz. The monolithic construction of these devices provides close electrical and thermal matching of the five transistors.



- 1. The collector of each transistor of these devices is isolated from the substrate by an integral diode. The substrate (Terminal 5) must be connected to the most negative point in the external circuit to maintain isolation between transistors and to provide for normal transistor action.
- 2. θ_{JA} is measured with the component mounted on an evaluation PC board in free air.

NOTE:

3. On small-geometry, high-frequency transistors, it is very good practice never to take the Emitter Base Junction into reverse breakdown. To do so may permanently degrade the h_{FE}. Hence, the use of I_{EBO} rather than V_{(BR)EBO}. These devices are also susceptible to damage by electrostatic discharge and transients in the circuits in which they are used. Moreover, CMOS handling procedures should be employed.




FIGURE 1. $h_{\mbox{\scriptsize FE}}$ vs COLLECTOR CURRENT




FIGURE 2. f_T vs COLLECTOR CURRENT




FIGURE 3. NOISE FIGURE vs COLLECTOR CURRENT




FIGURE 4. NOISE FIGURE vs COLLECTOR CURRENT




FIGURE 5. CAPACITANCE vs BIAS VOLTAGE






