

Note: The channel-to-ambient thermal resistance,  $R_{th(ch-a)}$ , and the drain power dissipation,  $P_D$ , vary according to the board material, board area, board thickness and pad area. When using this device, be sure to take heat dissipation fully into account.

Note 1: If a reverse bias is applied between gate and source, this device enters  $V_{(BR)DSX}$  mode. Note that the drain-source breakdown voltage is lowered in this mode.

Note 2: Let V<sub>th</sub> be the voltage applied between gate and source that causes the drain current (I<sub>D</sub>) to below (0.1 mA for this device). Then, for normal switching operation, V<sub>GS(ON)</sub> must be higher than V<sub>th</sub>, and V<sub>GS(OFF)</sub> must be lower than V<sub>th</sub>. This relationship can be expressed as: V<sub>GS(OFF)</sub> < V<sub>th</sub> < V<sub>GS(ON)</sub>.






Fig. 5.3.1 Test Circuit of Switching Time





Fig. 6.1 Marking




Fig. 7.1 I<sub>D</sub> - V<sub>DS</sub>





Fig. 7.3 R<sub>DS(ON)</sub> - V<sub>GS</sub>






Fig. 7.2 I<sub>D</sub> - V<sub>GS</sub>




Fig. 7.4 R<sub>DS(ON)</sub> - V<sub>GS</sub>





Fig. 7.6  $R_{DS(ON)}$  -  $T_a$ 







Fig. 7.8 |Y<sub>fs</sub>| - I<sub>D</sub>







Fig. 7.9 I<sub>DR</sub> - V<sub>DS</sub>








Fig. 7.12 Dynamic Input/Output Characteristics




Fig. 7.13 rth - tw




Fig. 7.14 PD - Ta





Fig. 7.15 Safe Operating Area
