
TSDF1220 Marking: F20 Plastic case (SOT 143)


1 = Collector, 2 = Emitter, 3 = Base, 4 = Emitter



TSDF1220W Marking: WF2 Plastic case (SOT 343)


1 = Collector, 2 = Emitter, 3 = Base, 4 = Emitter




Figure 1. Total Power Dissipation vs. Ambient Temperature




Figure 2. Transition Frequency vs. Collector Current




Figure 3. Collector Base Capacitance vs. Collector Base Voltage






Figure 4. Noise Figure vs. Collector Current


Dimensions of TSDF1220 in mm









Dimensions of TSDF1220R in mm










Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.

- 2. Class I and II ozone depleting substances in the Clean Air Act Amendments of 1990 by the Environmental Protection Agency (EPA) in the USA
- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
