The PS2715-1 is an optically coupled isolator containing GaAs light emitting diodes and an NPN silicon phototransistor in a plastic SOP for high density applications.










COLLECTOR CURRENT vs.
COLLECTOR TO EMITTER VOLTAGE




# TRANSISTOR POWER DISSIPATION vs. AMBIENT TEMPERATURE



#### COLLECTOR TO EMITTER DARK CURRENT vs. AMBIENT TEMPERATURE




COLLECTOR CURRENT vs.
COLLECTOR SATURATION VOLTAGE











# SWITCHING TIME vs.




## FREQUENCY RESPONSE




# CURRENT TRANSFER RATIO vs. FORWARD CURRENT




#### SWITCHING TIME vs. LOAD RESISTANCE



#### (4) Cautions

• Fluxes

Avoid removing the residual flux with freon-based and chlorine-based cleaning solvent.

## 2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between collector-emitters at startup, the output transistor may enter the on state, even if the voltage is within the absolute maximum ratings.
