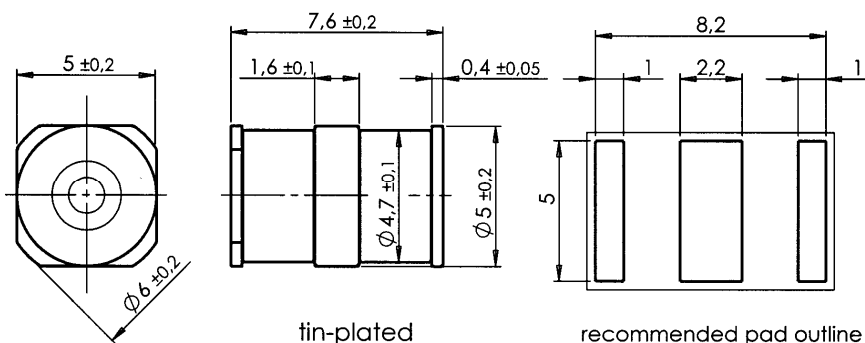

**Dimensional drawing**


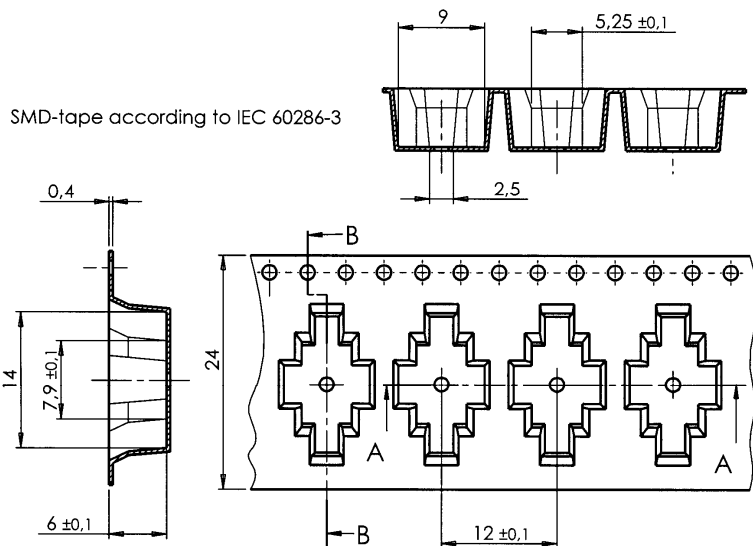
