Normalized Thermal Transient Impedance, Junction-to-Case



Backside view of dual pad





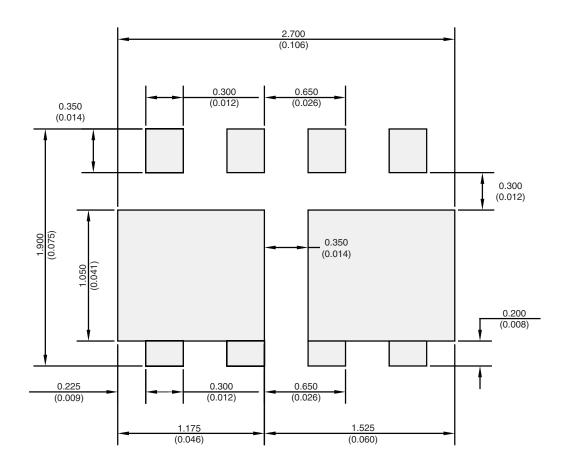
