




PACKAGE DIMENSIONS (in millimeters)











MAXIMUM LOAD CURRENT vs.


FORWARD VOLTAGE vs. AMBIENT TEMPERATURE




OUTPUT CAPACITANCE vs. APPLIED VOLTAGE



OFF-STATE LEAKAGE CURRENT vs. APPLIED VOLTAGE




LOAD CURRENT vs. LOAD VOLTAGE






TURN-ON TIME vs. FORWARD CURRENT



NORMALIZED TURN-ON TIME vs. AMBIENT TEMPERATURE




NORMALIZED ON-STATE RESISTANCE vs. AMBIENT TEMPERATURE



TURN-OFF TIME vs. FORWARD CURRENT




NORMALIZED TURN-OFF TIME vs. AMBIENT TEMPERATURE




ON-STATE RESISTANCE (N.O.) DISTRIBUTION




ON-STATE RESISTANCE (N.C.) DISTRIBUTION




TURN-ON TIME (N.O.) DISTRIBUTION




TURN-ON TIME (N.C.) DISTRIBUTION



TURN-OFF TIME (N.O.) DISTRIBUTION




TURN-OFF TIME (N.C.) DISTRIBUTION


