#### **Description**

TSFF5200 is a high speed infrared emitting diode in GaAlAs on GaAlAs double hetero (DH) technology, molded in a clear, untinted plastic package.

The new technology combines the high speed of DH–GaAlAs with the efficiency of standard GaAlAs and the low forward voltage of the standard GaAs technology.






Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature




Figure 3. Pulse Forward Current vs. Pulse Duration




Figure 4. Forward Current vs. Forward Voltage




Figure 5. Relative Forward Voltage vs. Ambient Temperature




Figure 6. Radiant Intensity vs. Forward Current




Figure 7. Radiant Power vs. Forward Current




Figure 8. Rel. Radiant Intensity\Power vs. Ambient Temperature




Figure 9. Relative Radiant Power vs. Wavelength




Figure 10. Relative Radiant Intensity vs. Angular Displacement





Figure 11. Attenuation vs. Frequency


