


Figure 1. Static Characterstic




Figure 3. V_{CE}(sat) vs. I_B Characteristics




Figure 5. Base-Emitter On Voltage




Figure 2. DC current Gain





Figure 4. Collector-Emitter Saturation Voltage





Figure 7. Power Derating
