


Figure 1. Static Characteristic




Figure 2. DC current Gain




Figure 3. Collector-Emitter Saturation Voltage Base-Emitter Saturation Voltage




Figure 4. Turn On, Storage and Fall Time vs Collector Current




Figure 5. Forward Bias Safe Operating Area




Figure 6. Reverse Bias Safe Operating Area




Figure 7. Derating Curve of Safe Operating Areas






Figure 8. Power Derating
