




Figure 1. Max. Thermal Resistance vs. Lead Length




Figure 3. Max. Reverse Current vs. Junction Temperature




Figure 2. Max. Reverse Power Dissipation vs. Junction Temperature





Figure 4. Forward Current vs. Forward Voltage





Figure 5. Max. Average Forward Current vs. Ambient Temperature

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
