

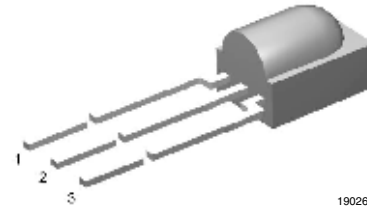
IR Receiver Modules for Remote Control Systems

Description

The TSOP38#.. series are miniaturized receivers for infrared remote control systems. A PIN diode and a preamplifier are assembled on a lead frame, the epoxy package acts as an IR filter.

The demodulated output signal can be directly decoded by a microprocessor. The TSOP382.. is compatible with all common IR remote control data formats. The TSOP384.. is optimized to suppress almost all spurious pulses from energy saving fluorescent lamps but will also suppress some data signals.

This component has not been qualified according to automotive specifications.

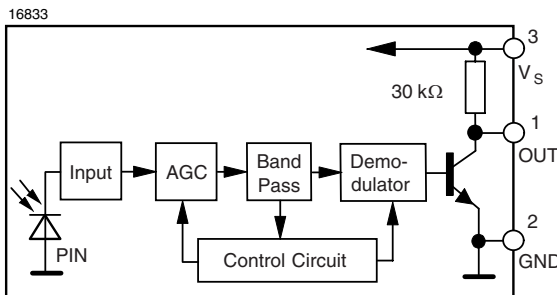

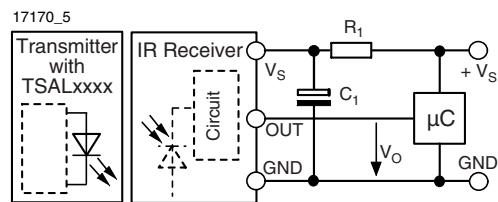

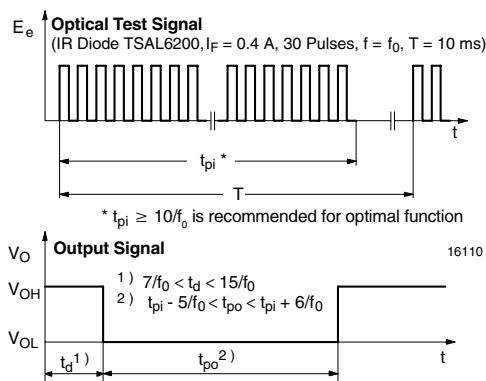


Figure 1. Output Active Low

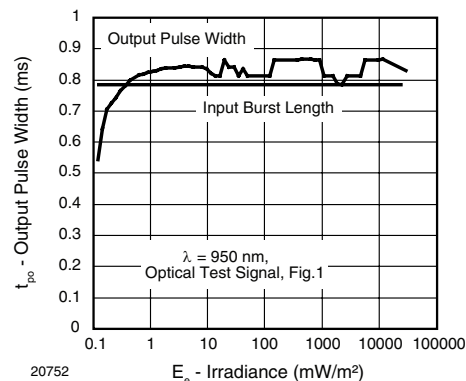


Figure 2. Pulse Length and Sensitivity in Dark Ambient

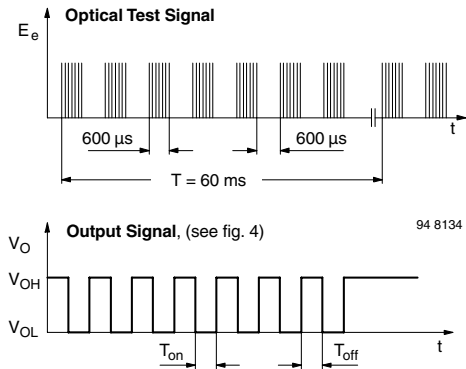


Figure 3. Output Function

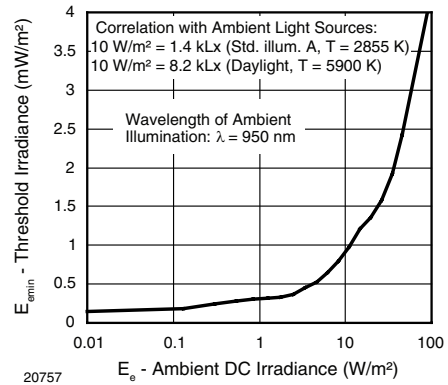


Figure 6. Sensitivity in Bright Ambient

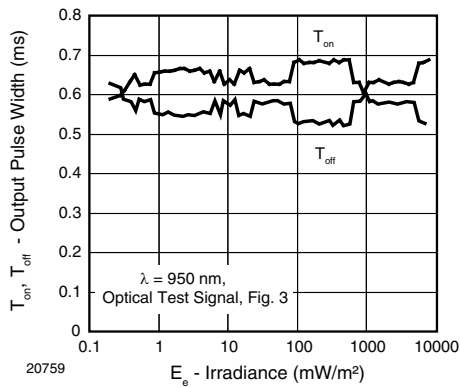


Figure 4. Output Pulse Diagram

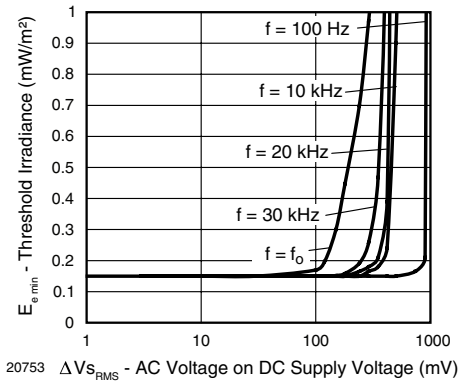


Figure 7. Sensitivity vs. Supply Voltage Disturbances

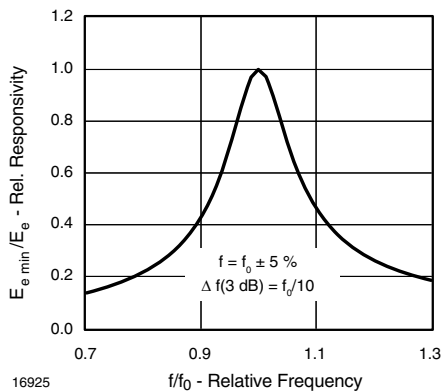


Figure 5. Frequency Dependence of Responsivity

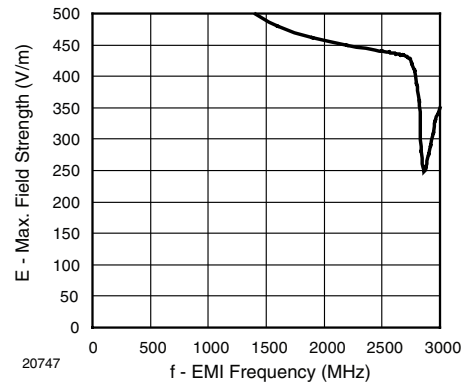


Figure 8. Sensitivity vs. Electric Field Disturbances

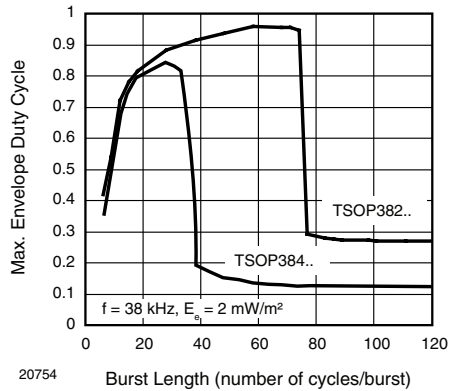


Figure 9. Max. Envelope Duty Cycle vs. Burst Length

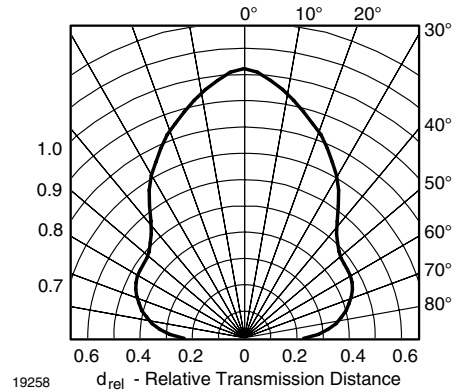


Figure 12. Horizontal Directivity

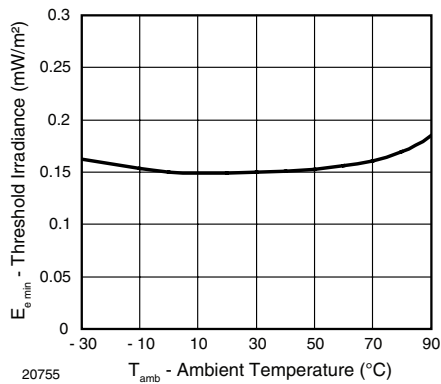


Figure 10. Sensitivity vs. Ambient Temperature

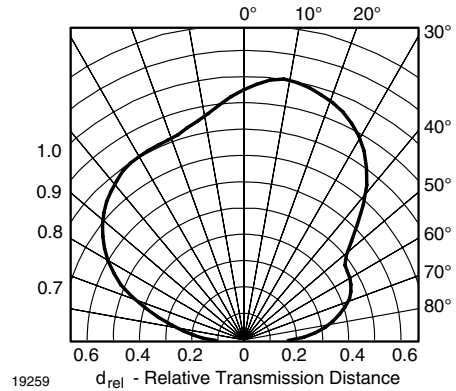


Figure 13. Vertical Directivity

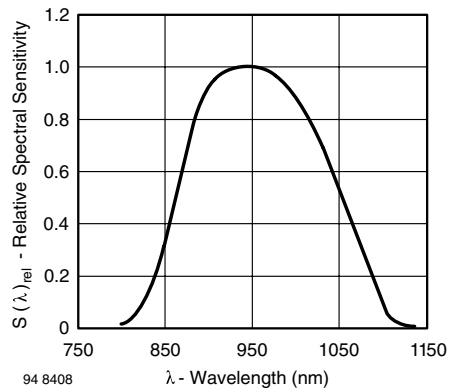


Figure 11. Relative Spectral Sensitivity vs. Wavelength

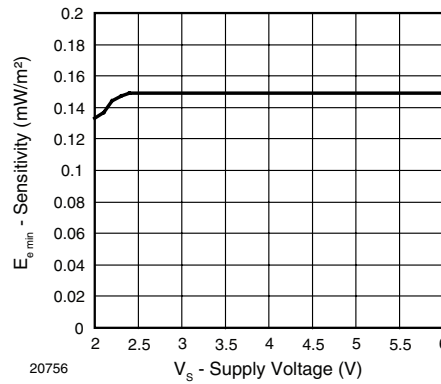


Figure 14. Sensitivity vs. Supply Voltage

Suitable Data Format

The TSOP38#.. series is designed to suppress spurious output pulses due to noise or disturbance signals. Data and disturbance signals can be distinguished by the devices according to carrier frequency, burst length and envelope duty cycle. The data signal should be close to the band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below.

When a data signal is applied to the TSOP38#.. in the presence of a disturbance signal, the sensitivity of the receiver is reduced to insure that no spurious pulses are present at the output. Some examples of disturbance signals which are suppressed are:

- DC light (e.g. from tungsten bulb or sunlight)
- Continuous signals at any frequency

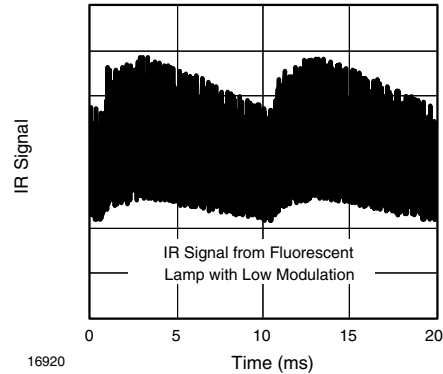


Figure 15. IR Signal from Fluorescent Lamp with Low Modulation

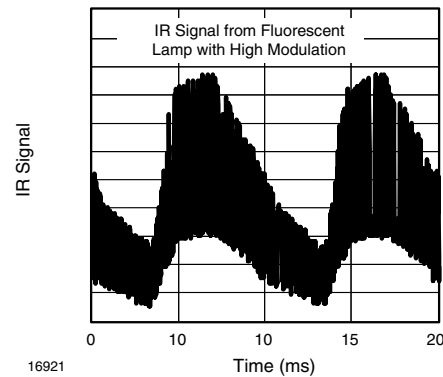


Figure 16. IR Signal from Fluorescent Lamp with High Modulation

- Strongly or weakly modulated noise from fluorescent lamps with electronic ballasts (see figure 15 or figure 16).

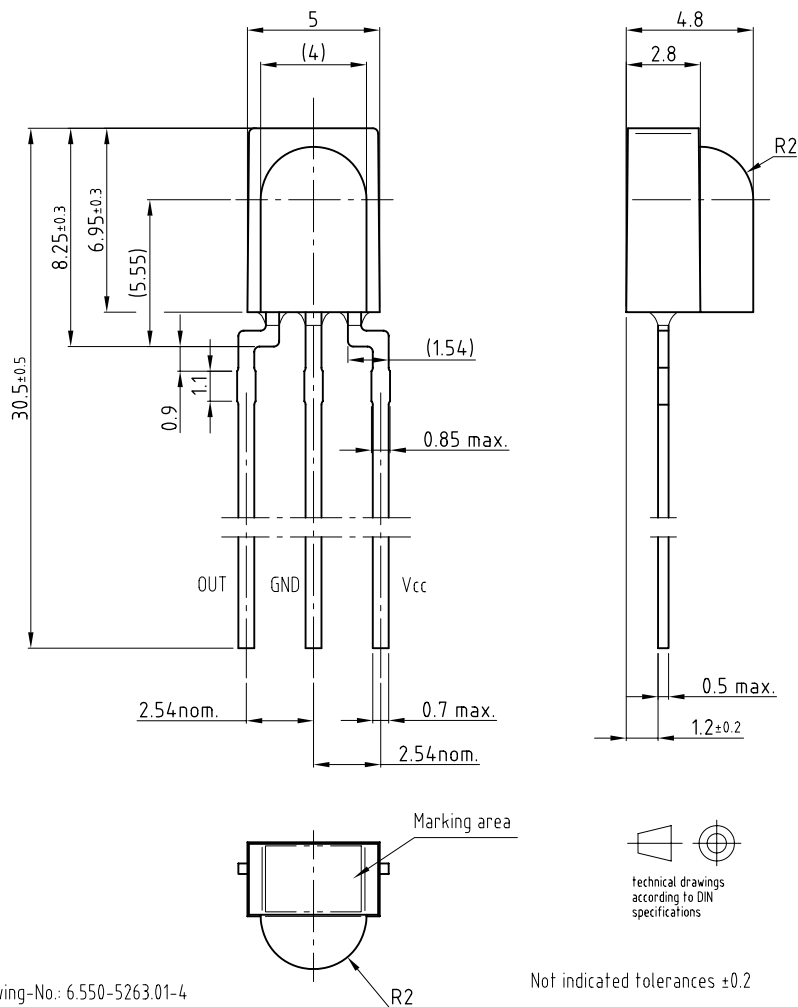
