




Figure 1. Typ. Reverse Current vs. Junction Temperature




Figure 2. Max. Average Forward Current vs. Ambient Temperature




Figure 3. Typ. Forward Current vs. Forward Voltage




Figure 4. Typ. Reverse Recovery Time vs. Forward Current








Figure 5. Typ. Reverse Recovery Charge vs. Forward Current





Figure 6. Thermal Response

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
