



Silicon PIN Photodiode

Description

BPW43 is a very high speed PIN photodiode in a standard $T-1^{3/4}$ plastic package. Due to its waterclear epoxy the device is sensitive to visible and infrared radiation.

It features low capacitance and high speed even at low supply voltages.

- Standard T-13/4 (ø 5 mm) clear package
- Angle of half sensitivity $\varphi = \pm 25^{\circ}$
- Suitable for visible and near infrared radiation






Figure 1. Reverse Dark Current vs. Ambient Temperature




Figure 2. Relative Reverse Light Current vs.




Figure 3. Reverse Light Current vs. Irradiance




Figure 4. Reverse Light Current vs. Reverse Voltage




Figure 5. Diode Capacitance vs. Reverse Voltage




Figure 6. Relative Spectral Sensitivity vs. Wavelength





Figure 7. Relative Radiant Sensitivity vs. Angular Displacement

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
