DESCRIPTION

The PS2503-1, -2, -4 and PS2503L-1, -2, -4 are optically coupled isolators containing a GaAs light emitting diode and an NPN silicon phototransistor.

The PS2503-1, -2, -4 are in a plastic DIP (Dual In-line Package) and the PS2503L-1, -2, -4 are lead bending type (Gull-wing) for surface mount.





PACKAGE DIMENSIONS (UNIT: mm)








Diode Power Dissipation PD (mW)








COLLECTOR CURRENT vs. **COLLECTOR TO EMITTER VOLTAGE**




COLLECTOR TO EMITTER DARK **CURRENT vs. AMBIENT TEMPERATURE**




COLLECTOR CURRENT vs. **COLLECTOR SATURATION VOLTAGE**






NORMALIZED CURRENT TRANSFER RATIO vs. AMBIENT TEMPERATURE



SWITCHING TIME vs. AMBIENT TEMPERATURE




FREQUENCY RESPONSE




CURRENT TRANSFER RATIO vs. FORWARD CURRENT




SWITCHING TIME vs. LOAD RESISTANCE





LONG TERM CTR DEGRADATION

NOTES ON HANDLING

1. Recommended soldering conditions



Avoid removing the residual flux with freon-based and chlorine-based cleaning solvent.

2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between collector-emitters at startup, the output transistor may enter the on state, even if the voltage is within the absolute maximum ratings.

★ 3. Measurement conditions of current transfer ratios (CTR), which differ according to photocoupler

Check the setting values before use, since the forward current conditions at CTR measurement differ according to product.

When using products other than at the specified forward current, the characteristics curves may differ from the standard curves due to CTR value variations or the like. Therefore, check the characteristics under the actual operating conditions and thoroughly take variations or the like into consideration before use.
