








# COLLECTOR CURRENT vs. BASE TO EMITTER VOLTAGE




# COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE




# REVERSE TRANSFER CAPACITANCE vs. COLLECTOR TO BASE VOLTAGE




# COLLECTOR CURRENT vs. BASE TO EMITTER VOLTAGE


